It is expected that the Order will be in effect for one day on the 20th April 2014 (1200 to 1315 hours)

Duke Street for its entire length

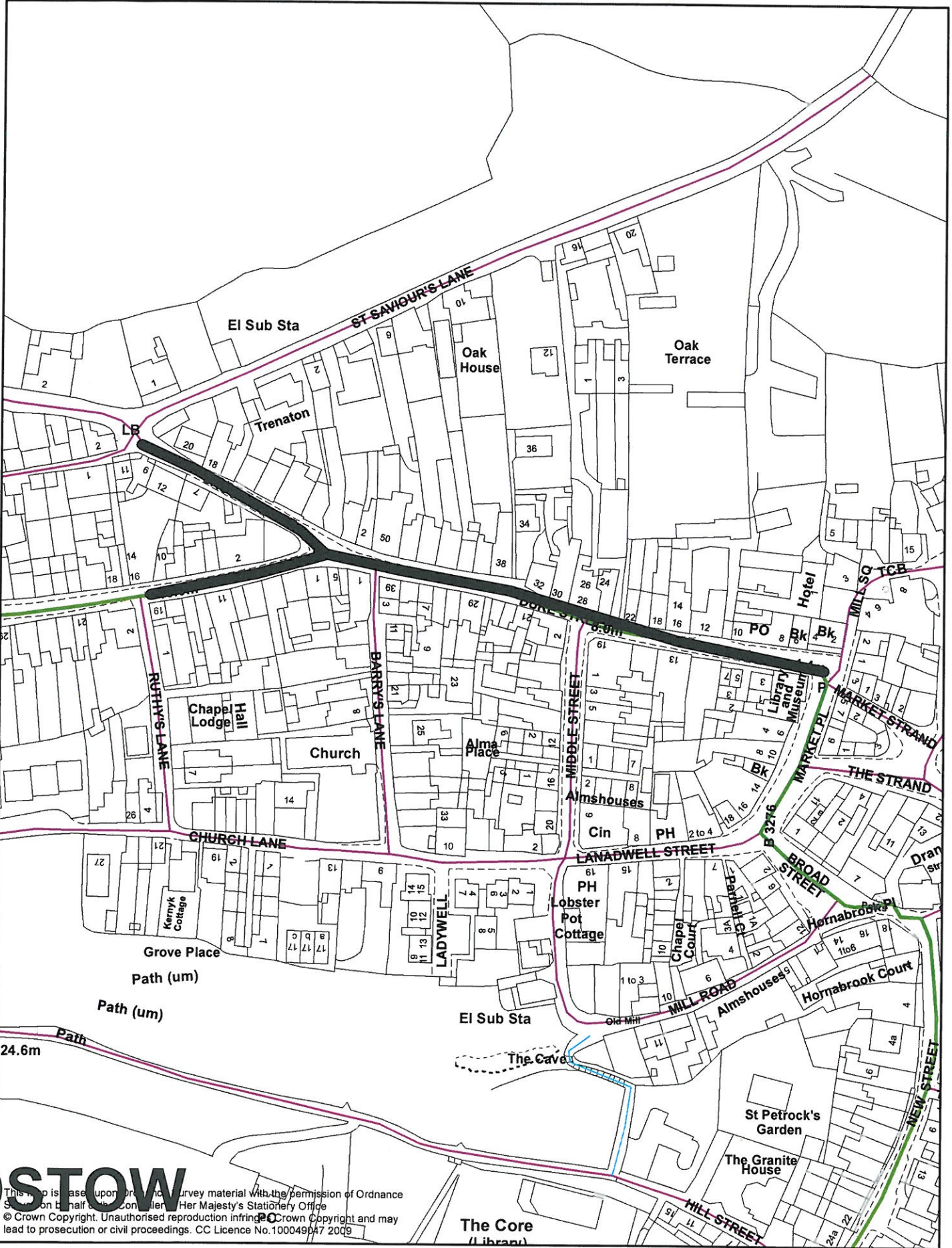

(RNLi Easter Egg Rolling Procession) Order 2014

Whereas Cornwall Council (hereinafter called "the Council") is the Traffic Authority for the Various Roads in Padstow in the said County

And Whereas the Council is satisfied that vehicular traffic on the said roads should by reason of RNLi Easter Egg Rolling Procession be prohibited and that exemptions are provided in the Order for emergency vehicles

And Whereas the Council is satisfied that a suitable alternative route exists for traffic affected by the Order

It Is Hereby Ordered in pursuance of Section 16(A) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Special Events) Acts 1994 that use by vehicles, except upon the direction or with the permission of a police constable in uniform of (Church Street Padstow between the junctions of Ruthys Lane and Cross Street Cross Street Padstow for its entire length and Duke Street Padstow for its entire length) be prohibited and that this order take effect from 20th April 2014
