Me and my husband Andrew Buckingham moved from London to Padstow in December 2018.
Andrew is a Padstownian born and bred but after 20 years living in London, we have both decided to return back to his home town to be closer to his parents. Being part of a smaller community/ town has been rewarding for us on so many levels and has given us the opportunity to have a better work/ life balance.

Currently I am working part time for the Padstow Brewing Co. at The Tasting Rooms on Broad Street. I have been working for the company since February 2019.
Working in town has showed me how busy Padstow gets during the year, how it can vary from month to month and how it can impact the day-to-day life of people who call this town home.

I have recently started volunteering for Padstow Brownies. I very much look forward to working with the other volunteers, spending time with and being a positive influence on the next generation of Padstow girls.

I have always worked in the private sector and my previous job was as a Facilities Manager for a well know managing agent of commercial properties in London.
My primary responsibilities were:
Support any occupier matters that may influence property valuation/investment. Setting and controlling of service charge budgets (up to 2 million).
Procurement of all supplies and services at the property in accordance with the Jones Lang LaSalle procurement program. This included the use of accredited contractors only, usually on the basis of framework agreements, and Jones Lang LaSalle's purchase ordering systems.
To understand the client's objectives and instructions in relation to each property.
Be first point of contact in client reporting on on-site facilities services.
Run smooth transition of properties into management and ensure readiness for sale, dealing with due diligence enquiries on disposal and lettings from a facilities perspective.

Ensure that on-site management of the properties was undertaken in accordance with Jones Lang LaSalle's facilities management best practice.
Liaise with occupier representatives on a regular basis and be the principal point of contact for advice and guidance in connection with the day-to-day physical operation of the building(s).
Quarterly variance reporting and reconciliation to agreed accounting practices.
Monitor contractor performance against agreed standards, regular KPI meetings.
Work on the buildings' environmental and social responsibility management activities, meeting with onsite staff and regular catch ups with the team managers.
Maintain the buildings' plant, equipment and building management systems where appropriate.
Implement minor works, subject to a predetermined budget and control all routine expenditure.
Prepare site regulations, review RAMS and issue permits to work for all contractor activities on site.
Maintain, test and implement disaster planning procedures to cover all emergencies.
Organise and co-ordinate fire evacuation and bomb drills.

I have a logical approach to challenges, a strong background of client facing roles and the ability to work within strict deadlines. I am enthusiastic and quick to grasp new ideas and concepts and keen to learn new skills and increase my knowledge.
I have IOSH (Institution of Occupational Safety and Health) qualification which I achieved while working for the managing agents in London.
I have managed all Risk Assessments and Method statements on behalf of the contractors we had on site.
Day to day operation of the large buildings felt like running a small town. In some buildings we had occupancy as high as 1000+ people not counting the visitors on daily basis.
Being a FM has taught me how to juggle lots of tasks at the same time but keep calm and provide the best customer service at all times.
I built close working relationships with all on-site contractors (security, cleaning team, front desk team, engineering etc). This helped me to tackle daily challenges in a professional way whilst maintaining a fun and positive atmosphere in the work place.

I am a chartered member of the Institute of Occupational Safety & Health (CMIOSH.) My key focus and speciality is developing safety management programmes for the business – improving consultation structure with staff and stakeholders. I am currently working to deliver a new EHS programme for my employer over three years that will target the ISO 45001 and ISO 14001 certifications (for safety and environmental management, respectively.)

As part of a Steering Group in the business, I help direct strategy as well as delivery on a range of ESG (Environment; Social; Governance) programmes, including developing an improvement plan strategy to improve the company CDP score (Carbon Disclosure Project), targeting ESG improvements such as proactive EHS management to ISO standard; reducing environmental impacts with our partners and suppliers; developing a supplier code of conduct, whistleblowing, anti-bribery & corruption policies and gaining Board approval on these.

I have also been working for 2 years to improve the Security for the Group, applying an Enterprise Risk Management approach to Security Policy and practice. In the past, I have also liaised with the Police on matters of terrorism directly affecting our business.

As a Facilities Director, I am working to deliver a key £50M expansion Facility project, relocating our Chippenham based campus of R&D plus manufacturing operations to a new greenfield site in Bristol & Bath Science Park. I have lead status on obtaining the coveted BREEAM and WELL certifications for sustainable building in this venture. I have delivered multiple large £seven figure projects in the UK, Singapore, and on both east and west-coast USA.

My departmental operating expenditure per annum in my current role is circa £3M, minus rents – I'm used to managing budgets for both OpEx and also Capital investment projects.
