Churchyard Cremation Plot: Useful Information Sheet

Reservation Holder

The person(s) named above will be registered as the Reservation Holder of the afore mentioned plot in the area for cremated remains in the churchyard of the Church of St. Petroc's, Padstow. No interment may take place and no memorial may be arranged without an application signed by the Reservation Holder or in the event of their death the lawful next of kin. Reservation is granted for a period of 99 years from date of reservation.

Memorial Conditions - Churchyard Cremation Plots

Permission to place a memorial tablet must be obtained from Padstow Town Council by way of g a completed Monumental/Memorial Application Form. Subject to such approval, memorial tablets can be placed immediately following an interment.

Memorials for the churchyard cremation area extension (denoted by a plot number ending "CHYD EXT") are to be stone tablets 15" by 12" in size with an integral vase hole in the upper left hand corner.

Memorials for the original churchyard cremation area (denoted by a plot number ending "CHYD" to be stone tablets 9" by 9" in size except in rows M, P, Q and R where they are to be 12" by 9".

For all areas Stone is restricted to the varieties listed in the Diocesan Churchyard Regulations namely:

- Granite: Preferred Silver grey, quarried in Cornwall and Devon
- Permitted Tarn (France), Karin (Finland), Marlow (Portugal)
- Slate: Cornish, Welsh Blue and Grey, Lakeland Green and Grey.

No other materials are permitted. In particular blue, red, black and dark grey granites, white marble, synthetic stone and plastic are not permitted.

All memorial conditions are complicit with Faculty agreement.

Tributes for a grave

The placing on graves of glass containers or shades, items of pottery, tins, plastic or wire mesh fences or other items of metal, plastic or other material are forbidden and will be removed without notice. The Council reserves the right to remove from any grave space flowers, plants, floral tributes, wreaths or receptacles which have deteriorated or become unsightly and dispose of them in such manner as they deem fit.
