Notice of Reservation of Cremation Plot

To reserve a cremation plot in Padstow Cemetery an Exclusive Right of Burial (EROB) must be purchased. Please note, **only the rights of burial are purchased and not the land itself** which remains the property of the Council.

Please complete sections 1 and 2 of the Notice of Reservation Form and read the important information in section 3 before returning the completed form, together with the relevant fee, to Padstow Town Council, Station House, Station Road, Padstow, PL28 8DA. Alternatively, forms can be returned by email to enquiries@padstow-tc.gov.uk.

Payment can be made by BACS to Padstow Town Council, Sort Code 30 98 98, Account Number 00620229. Alternatively, a cheque made payable to Padstow Town Council can be sent to the Council Offices at the address above.

Section 1: Exclusive Right of Burial Ownership Details

The person(s) named below will become the owner(s) of the Exclusive Right of Burial (EROB) and the Deed of Grant will be registered in their name(s). Where there is to be more than one owner, the deed will be issued by post to the person listed on the notice as Owner 1. The EROB is granted for a period of 99 years. No memorial may be arranged and no interment may take place without the signed consent of the EROB owner(s). Except in the case of an EROB owner's interment; an EROB owner has an automatic right of burial and no permission is required.

Section 3: Padstow Town Council Cemetery Regulations

The Cemetery operates in accordance with the Padstow Town Council Cemetery Regulations and EROB owners are required to comply with these at all times. A copy of the regulations can be viewed online at <https://padstow-tc.gov.uk/local-services/padstow-cemetery/> Alternatively, a hard copy can be made available upon request for which a small fee may apply.

Padstow Town Council grants EROB owners the right to place a memorial upon submission of Memorial Application. **The regulations provide specific detail regarding permitted memorials.** Extracts from the current regulations regarding memorials include but are not limited to:

- All memorials to be a 15" x 12" tablet with integral vase in upper left hand corner [in the cremation extension area].
- The placing on graves of glass containers or shades, items of pottery, tins, plastic or wire mesh fences or other items of metal, plastic or other material are forbidden and will be removed by the Council without notice.

Please note, the regulations and burial fees and charges are subject to change and may at the time of burial be different to those at the time of the EROB purchase.
