











A tablet that is 18" x 18" would be more noticeable and is a better space for wording memorialising 2 people. Should be specified that tablets are placed on concreate – would be better protected from mowing/strimming.	6

1	You need to ensure that these rules are followed. On many occasion I have gone to cremation plot to place flowers and certain areas are over run with memorabilia	9
3	I believe you should let relatives plant small flowers and place memorabilia on their family graves as they see fit. If it is going to be a h&s issue then families would understand and tend to the plots themselves.	10

Prior to 2014 there was no designated dimensions to the Original Cremated remains site and in a lot of cases areas adjacent to memorial plaques have been used for mementoes, vases and the planting of bulbs etc. You must remember that a lot of the much older Cremation plaques do not have any facility for a vase within	14
